STEP 1: CREATE A COLORADO PARKS AND WILDLIFE ACCOUNT

Go to cpwshop.com and create an account. Fill out your personal information and let us take care of the rest. Budge's handles all applications in the CPW draw system as part of our services. We will submit your application on your behalf to ensure accuracy and a successful draw. PLEASE CAREFULLY NOTE YOUR CID NUMBER AND PASSWORD.

Hunt Options (check preferences):

- Lodge Hunt: hunting by horseback with cabin accommodations
- Wilderness Camp: hunting on foot from a remote wall tent camp
- 1-on-1 Guided Hunt: \$6,980
- 2 Hunters Per Guide: \$5,980 (only select this option if you are booking with a partner and wish to share a guide)

By booking your limited archery or muzzleloader hunt now, you're locking in the current pricing. Any future price increases will not apply to you.

All hunts include 5 full days of guided hunting, accommodations and meals. Does not include hunting license, CPW application fees, gratuities or transportation to and from the lodge. Please see the CPW Big Game Brochure or ask us about license and application costs.

STEP 6: POWER OF ATTORNEY PROGRAM CONTRACT

STEP 7: SEND DEPOSIT & RETURN THIS FORM

PAYMENT SCHEDULE:

- \$500 deposit: Due now. This holds your spot at current rates.
- 50% of the hunt fee: Due immediately upon successfully obtaining your license
- Balance: Due the 1st of August, preceding your Archery or Muzzleloader Hunt

A \$500 non-refundable deposit is required to secure your spot on a limited license archery or muzzleloader elk hunt. This is a one-time deposit and will be applied toward the cost of your hunt when you draw. Each year that you do not draw, this deposit will be rolled over to the following year. This contract and your deposit do not expire, and will remain valid until you obtain your license.

When you obtain your license, we will send you the hunt contract. The signed contract and 50% deposit will be due immediately. The final balance will be due August 1st.
